

THE ANTIQUITIES LAW
(Cap. 31 until L.103 (I) of 2012)

Notice by virtue of the provisions of article 10(4) of the Antiquities Law,
Cap. 31 until L.103 (I)/2012.

Designation of areas where the use of metal detectors is permitted

The Minister of Communications and Works, exercising the powers vested in him by paragraph 4 of section 10 of the Antiquities Law, Cap.31 until L. 103(I)/2012 and for the purposes referred to in the aforementioned paragraph, shall specify the following areas that are described in Tables 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 below, as the only areas where the possession and use of metal detectors or other devices is permitted, after obtaining a license in writing, from the Director of the Department of Antiquities.

AREA 1: Protaras

The area that is defined in the east by the coastline and in the north by a road that begins from Agia Triada round-about and ends at Agia Triada bay. In the west it is defined by Vrysoudes Street, then by Pinias Street and Perneria Avenue and then by the road that leads to the coast, in front of 'Anastasia Beach' Complex, as bordered by the yellow line on Plan No.1, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 2: Agia Napa

The area that is defined in the south by the coastline and in the west by Nisi Beach, up to 'Adam's Hotel'. In the north the area is defined by Nisi Avenue and then, by Makarios III, Petraki Giallourou and 1st of October streets, Kryou Nerou Avenue and then Cavo Greko Avenue, while its eastern limit is defined by Hellas Street, as bordered by the yellow line on Plan No.2, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 3: Larnaka

The area that is defined in the east by the coastline and in the north by the crossroad of Voroklini Fire Station and 'Henipa Hotel'. In the west it is defined by Larnaka-Dekeleia Avenue and then, by Ammochostos Avenue, Makarios III Avenue, Zenonos Kitieos Street, Piale Pasia Avenue up to Makenzi Beach. Its southern limit is defined by the fence of the Larnaka International Airport,

as bordered by the yellow line on Plan No.3, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 4: Pervolia

The area that is defined in the south and the east by the coastline and in the north by the 'Journalist Village'. It is also defined by Faros Avenue, Arch. Makarios III Avenue and the coastal road to the south of Arch. Makarios III Avenue that intersects with it 200 metres to the southeast of the 'Marios Apartments' Complex up to the mouth of Tremythos River, as bordered by the yellow line on Plan No.4, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 5: Parekklesia

The area that is defined in the south by the coastline and in the west its limit is the 'Elias Beach Hotel' pier. In the east, it is defined by the beach in front of the 'Le Meridien' Hotel. 'St Raphael' Marina is not included in this area. In the north it is defined by the pedestrian path that leads from 'Elias Beach Hotel' to 'St. Raphael' and then by the coastal pathway and the pedestrian path to the south of the 'Le Meridien', as bordered by the yellow line on Plan No.5, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 6: Germasogeia

The area that is defined in the south by the coastline and in the west by the Embankment. Its eastern limit is 'Dasoudi' area of Germasogeia and the Swimming Pool of the Cyprus Sports Organisation. In the north it is defined by the Lemesos coastal road (28 Oktovriou Avenue and Georgios A Avenue), as bordered by the yellow line on Plan No.6, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 7: Petra tou Romiou

The area that is defined in the south by the coastline and in the east by the southwestern limit of Petra tou Romiou beach. Its western limit is the mouth of the Ha Potami River, while its northern limit is the old Lemesos-Pafos road, as bordered by the yellow line on Plan No.7, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 8: Geroskipou

The area that is defined in the south by the coastline and in the east by the mouth of Ezousa river. Its western limit is the CTO coastal restaurant, while its northern limit is the coastal road, as bordered by the yellow line on Plan No.8, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 9: Kisonerga

The area that is defined in the west by the coastline and in the south by Potima Beach. In the north it is defined by the mouth of Mavrokolympos river, while in the east it is defined by the coastal road, as bordered by the yellow line on Plan No.9, prepared by the Cartography Branch of the Department of Lands and Surveys.

AREA 10: Polis Chrysochou

The area that is defined in the north by the coastline and in the east by the beach to the west of the camping site. In the west it is defined by the Latsi Harbour embankment while in the south it is defined by the coastal dirt road, as bordered by the yellow line on Plan No.10, prepared by the Cartography Branch of the Department of Lands and Surveys.
