E) COVID-19 INFORMATION:

ALL PASSENGERS ARRIVING IN THE REPUBLIC OF CYPRUS ARE REQUIRED TO UNDERGO EITHER A RT-PCR TEST, 72 HOURS BEFORE DEPARTURE OR AN ANTIGEN RAPID TEST, 24 HOURS BEFORE DEPARTURE. IT IS REMINDED THAT UPON ARRIVAL ALL PASSENGERS, REGARDLESS OF THEIR VACCINATION STATUS, WILL UNDERGO A PCR LABORATORY TEST AND THE COST WILL BE BORNE BY THE PASSENGER. MOREOVER, ALL PASSENGERS, ENTERING THE REPUBLIC OF CYPRUS, EXCEPT OF THOSE WHO RECEIVED THE BOOSTER DOSE OF ACCEPTABLE VACCINES ARE REQUIRED TO UNDERGO A RAPID ANTIGEN TEST UPON COMPLETION OF 72 HOURS FROM THE TIME OF THEIR ARRIVAL. PERSONS UNDER THE AGE OF 12 TRAVELING IN THE REPUBLIC OF CYPRUS ARE NOT REQUIRED TO UNDERGO DIAGNOSTIC TESTS FOR COVID-19.

PASSENGERS ARRIVING IN THE REPUBLIC OF CYPRUS REFUSING TO UNDERGO A PCR LABORATORY TEST UPON ARRIVAL, WILL BE PLACED IN STATE QUARANTINE FOR A PERIOD OF 14 DAYS AND WILL BE RELEASED ON THE 7TH DAY, SUBJECT TO PERFORMING A PCR LABORATORY TEST. THE COSTS OF THE STATE QUARANTINE AND TESTING WILL BE BORNE BY THE PASSENGER.

BE INFORMED THAT ALL PASSENGERS WITH NO EXCEPTION MUST COMPLY TO A RANDOM LABORATORY TEST UPON ARRIVAL AND ALSO THAT ALL PASSENGERS ARE OBLIGED TO APPLY FOR THE CYPRUSFLIGHTPASS WITHIN 48 HOURS BEFORE THE DEPARTURE OF THEIR FLIGHT.
