Only the DCA Inspector or Senior Examiner conducting the assessment of competence may sign this Temporary Certificate after verifying the applicant has fulfilled all the applicable requirements and the application is accompanied by a valid completion certificate from the relevant Approved Training organisation (as required).

Any Temporary Certificate issued when the applicable requirements have not been fully met will be, immediately, provisionally suspended and the subsequent application may be rejected.
