## **GUIDANCE NOTES**

- The amount of 205.05 is paid for every application irrespectively of the License Categories/ Subcategories which are enlisted on the application form.
  - e.g. application for categories B1.1 +B1.2+B2+C = Total amount 205.05
- The amount of 85.45 is paid for every aircraft type rating irrespectively of the license categories in which this rating will be endorsed.

e.g.

- > application for endorsement of a type rating on categories B1.1 & B2, the total amount will be 85.45.
- application for endorsement of type ratings A319/320/321 (V2500) & A318/A319/A320/A321 (CFM56) on category B1.1, the total amount will be 85.45\*2 = 170.90
- application for endorsement of type ratings A319/320/321 (V2500) & A318/A319/A320/A321 (CFM56) on categories B1.1 & B2, the total amount will be 85.45\*2 = 170.90
- 3 Except upon marriage, divorce or address change
