### ENGLISH LANGUAGE PROFICIENCY ASSESSMENT

#### **GUIDANCE NOTES**

## General Guidance

- a. ICAO has published a Standard that requires flight crew of aircraft using radiotelephony to be proficient in the language used for communication. For domestic flights the language may be that of the State concerned, but for international flights the language must be English. This Standard becomes obligatory from 05 March 2008.
- b. All aeroplane, powered lift aircrafts and helicopter pilots, need to hold valid language proficiency endorsement for radio communication. Cyprus DCA can only endorse English language proficiency levels on the licenses issued by the Department.
- c. Applicant's language skills will be rated on a scale of 1 to 6 (as defined by ICAO) and must achieve a minimum of level 4. If the applicant achieves level 6 he/she will not need to be re-evaluated. However, if level 4 or 5 is achieved, he/she will need to be re-evaluated as follows:
  - Level 4 every 4 years from the date of assessment
  - Level 5 every 6 years from the date of assessment

The applicant will then have a language proficiency endorsement on his/her license, and a validity date.

If you are graded below a level 4, you will not be able to get an EASA Part-FCL license.

# **Guidance for Applicants**

- a. A formal evaluation of English Language Proficiency will take place at the Department of Civil Aviation Cyprus (DCAC) Training Centre at Kokkinotrimithia Industrial Area, Nicosia.
- b. Applicants will have to submit application form LIC-038 and the receipt of the payment to the Licensing section.

# Application will not be processed until the applicable charges have been received.

- c. Applicant who was informed for a final examination date but will not be able to attend, should inform in writing (preferably by email) the DCA at least two (2) working days before examination date. In such a case, the applicant should also give a preferred period for the new examination to take place.
  No additional fees will be charged.
  Only one (1) cancellation request per applicant will be allowed. For a further cancellation, a new application form should be submitted together with the applicable fees.
- d. Applicants are requested to be presented at Training Center's premises not earlier than 20 min before examination time.

Applicant who does not appear on time for the examination, without DCA's prior notification and consent, will be disqualified and a new application will have to be submitted together with the applicable fees.
