## **GUIDANCE NOTES**

- For each Rating to be endorsed e.g. Application for endorsement of SEP and MEP (2 class ratings) --> Payment: 68.34 + 68.34 =Total 136.64
- 2 Class Rating e.g. Aeroplanes classes SEP (land), SEP (sea), MEP (land), MEP (sea)
- 3 For each Class Rating Renewal e.g. Application for Renewal of SEP and MEP
  - --> Payment: 68.34 + 68.34 =Total 136.64
- 4 Renewal of a rating or certificate means the administrative action taken after a rating or certificate has lapsed for the purpose of renewing the privileges of the rating or certificate for a further specified period consequent upon the fulfilment of specified requirements.
- 5 Except upon marriage, divorce or address change
- 6 Candidate applying for skill test for MEP (class rating) and Instrument Rating (IR) (addition class and IR)
  - --> Payment: 136.69 + 136.69 = Total 273.38

- 7 Candidate applying for theoretical examinations for subjects Meteorology and Air Law
  - --> Payment: 17.09 + 17.09 =Total 34.18
- 8 Initial Type Rating for Initial issue of CPL(A) may not be applicable (Candidate may apply after completing the type training course in an ATO and the skill test )
- 9 For each rating Renewal e.g Application for renewal of MEP (Class) and A320 (Type)
  - --> Payment: 68.34 + 68.34 =Total 136.64

- In the case where the flight test is conducted by external persons authorized by the
  competent authority, the relevant fee will be increased by 10 per cent (10%) and will be
  collected by the competent authority
