

ANNOUNCEMENT **AVAILABLE TRAFFIC RIGHTS** **FOR JORDAN**

The Department of Civil Aviation as the Competent Authority based on the Decision of the Minister of Communications and Works for the allocation of Scarce Traffic Rights with Third Countries, Statutory Instrument Act 406/2008, (Official Gazette of the Republic of Cyprus, Supplement III (I), No. 4312, dated 07/11/2008), and which was republished in the Official Journal of the EU (C56/37 dated 10.3.2009), informs European airlines (including air carriers of EEA countries) that, based on the provisions of the Euro-Mediterranean Aviation Agreement between the European Union and its Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part, there are available traffic rights, without restrictions as to the number of airlines, weekly frequencies and capacity on the following route:

1. Points in the European Union – One or more intermediate points in Euromed countries*¹, ECAA countries*² or EFTA countries*³ – One or more points in Jordan.

The airlines that are interested in operating the routes should submit their interest to the Department of Civil Aviation at the following address:

Note: The designated airlines will be entitled to 5th freedom traffic rights to/from King Hussein International Airport. Additionally, the designated airlines will be entitled to full 5th freedom traffic rights without any restriction, in both passenger and all cargo services, on a list of points included in the attached list. Finally, the designated airlines will be entitled to 5th freedom traffic rights according to the provisions of the Euro-Mediterranean Aviation Agreement between the European Union and its Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part, and subject to the decision of the Joint Committee established according to the provisions of this Agreement.

*¹ "Euromed Countries": Morocco, Algeria, Tunisia, Libya, Egypt, Lebanon, Jordan, Israel, the Palestinian Territory, Syria and Turkey.

*² "ECAA Countries": are the countries which are parties to the Multilateral Agreement establishing a European Common Aviation Area: Member States of the European Union, Albania, Bosnia and Herzegovina, Croatia, the Former Yugoslav Republic of Macedonia, Iceland, Montenegro, Norway, Serbia and Kosovo under UN Security Resolution 1244.

*³ "EFTA Countries": Iceland, Liechtenstein, Norway and Switzerland.

- a) North America;
- b) South Africa, Uganda, Kenya, Tanzania;
- c) Turkey;
- d) Middle East (except Alexandria, Baghdad, Erbil, Bahrain, Beirut, Cairo, Damascus, Jeddah, Riyadh, Sharm-el Sheikh)
- e) Russia (except St. Petersburg and Moscow); and
- f) Denmark, Finland, Latvia, Lithuania, Luxemburg, Malta, Norway, Portugal, Slovakia, Sweden, Slovenia, Spain, Austria (except Vienna), and France (except Paris).
